3. Supervising the Board of Management by the Board of Directors

The Board of Directors consistently monitors the operational activities of the General Director, the management team assisting the General Director, and the appointed representatives of the Corporation at its subsidiaries in implementing the resolutions of the Annual General Meeting of Shareholders and the resolutions and decisions of the Board of Directors, specifically in the following areas:

- Organizing a review of the Corporation's internal regulations, evaluating existing issues and/or occurrences, and implementing amendments and supplements, and ensuring the enforcement internal regulations in a unified manner to ensure compliance with legal provisions, positively impacting the Corporation's operational activities.
- Approving resolutions and decisions, directing business, financial, investment activities, labor and wage management, organizational structure and human resources, etc
- Overseeing the development and implementation of the 2025 business plan for the Corporation and its subsidiaries and affiliates
- Supervising the activities of the General Director and management staff as follows
- + The Board of Directors reviews, evaluates, and approves reports from the General Director regarding progress, results of business operations on a quarterly, semi-annual, and annual basis, identifying difficulties, analyzing causes, and proposing solutions.
- + The Board of Directors closely monitors and directs the activities of the Board of Management, timely addressing issues within the Board's authority, providing support and creating favorable conditions for the Board of Management's operations.
- + Regularly monitoring the compliance of the management and operational team with applicable laws and internal regulations to manage the Corporation, mitigate risks, control internal processes, and address business ethics issues; maintaining relationships with stakeholders, including shareholders, employees, suppliers, and customers.
- Conducting regular and unplanned inspection of financial accounting, ensuring compliance by the Board of Management and the internal control system at the Corporation and its subsidiaries.
- Monitoring the implementation of additional capital contributions at subsidiaries, affiliated companies and the issuance of loan guarantees for subsidiaries at banks.
 - Monitoring and expediting the collection of receivables.
- Successfully organizing the 2025 Annual General Meeting of Shareholders, ensuring compliance with legal procedures; presenting key business plans for the Corporation in 2025, restructuring the personnel of the Board of Directors, Board of Supervisors for Term II (2021-2026).


